We are writing to invite you to support the development of the Being Peace Practice Centre by making a pledge to donate a specified amount at a defined moment in the future.



Donation Amount

Governing Law

5. This Agreement will be construed in accordance with and governed by the laws of the Country of England.

Amendments

6. This Agreement may only be amended or modified by a written instrument executed by both the Donor and the Recipient.

General Provisions

7. Headings are inserted for the convenience of the parties only and are not to be considered when interpreting this Agreement. Words in the singular mean and include the plural and vice versa. Words in the masculine mean and include the feminine and vice versa.

Entire Agreement

8. This Agreement constitutes the entire agreement between the parties and there are no further items or provisions, either oral or otherwise.

Gift Aid Declaration

9. Please let us know if we can claim Gift Aid on your donation. If you don't know currently whether we may claim or not, or if we may be able to claim for some years but not others, please let us know this via email.

- I am a UK taxpayer and I want Plum Village UK to claim back the tax on all donations I have made in the last four years, and all future donations.
